

Brief History

301 North Market Street Building Frederick, Maryland

The origins of the Building date back to 1745, when Daniel Dulany laid out the original plat of Frederick, with sub-feudal authority, defining the Building's lot, as it still exists today. The lot was designed for a grand Colonial home and off-street parking with its stables extending behind the adjacent lot. The French and Indian War delayed construction of the Building until the 1770s. Its first owner Richard Potts was a Revolutionary War, hero who served in Governor Thomas Johnson's "Flying Camp" and as a Member of the 1st Continental Congress in 1781 and the Maryland Convention in 1778, which ratified the U.S. Constitution, establishing the USA.





President George Washington then appointed Potts as the first US Attorney for Maryland, and in 1792, Potts was elected to the US Senate for Maryland, replacing legendary signer of the Declaration of Independence Charles Carroll of Carrollton. Potts later served as 1st Circuit Court Judge in Frederick, where his portrait hangs today. He died in 1808, and according to family records, in the early 1830s, his 2nd wife Eleanor Potts, moved to Council Street, where her first cousin Francis Scott Key visited her. Key's parents are buried in the Potts Family plot at Olivet cemetary.

In a 1974 article, a Frederick newspaper recounted that the Building was constructed as a residence before 1778. The large building with its massive fireplaces, hand-hewn timbers and lathe with horsehair-plaster walls were covered with beautiful Colonial wallpaper and supported on timbers salvaged from an earlier log cabin. An analysis of construction techniques indicated that it was built by the German shipbuilders from Schifferstadt. As downtown Frederick emerged and grew commercially, the Building found itself on the main shopping street of the town. At some point, it became the "Glove Inn" according to descendants of a subsequent owner, who ran a dry-goods store on the 1st floor before selling the Building in 1858. With an 1860 addition and construction where the Colonial stables had been located, the Building's lot was filled to its limits. Use of the Building as a dry-goods/hardware store continued in varying forms into the 20th Century. Just prior to the 2013 sale, the Building housed a clothing and costume jewelry store and two residential apartments.

At the establishment of Maryland's Registry of State Historic Sites in 1975, the Building was cited as the "oldest Commercial Building in Frederick." After half a century of neglect, however, this prominent corner Market Street building was in need of major repair and refurbishment. The current owners since 2013, Michele Fontaine and Francis Skrobiszewski, established an LLC for the purpose of renovating the entire envelope of the Building to house Upmarket Coffee, Inc.'s European-style café and their residence, with surplus bedrooms, all of which include new modern private baths, available for overnight guests. Fontaine owned and operated a retail culinary, coffee, tea, chocolate and housewares store on Connecticut Avenue in DuPont Circle for over 30 years.





They renovated and brought up to code this mixed-use structure spanning four centuries of construction (18th, 19th, 20th and now 21st) to unveil a transformed space at 301 Market Street, into a beautiful Café and Inn. The finished product represents a significant effort in maintaining Frederick's heritage, while providing Frederick residents and tourists alike an elegant, old-world dining experience and up-dated lodging in a historic setting.
